TERMS AND CONDITIONS

This Customer Account and Credit Application (“Application”) is made to JJC Georgetown (“Events N Yu”) for the purpose of inducing Events N Yu to extend credit accommodations to the Applicant named below, and in accordance with the following terms:

1. Upon approval of this Application, Events N Yu, in its sole discretion, and notwithstanding any request of Applicant, shall have the right to terminate Applicant’s credit privileges under this Application at any time without prior notice to Applicant, except otherwise provided by law.
2. All purchases by Applicant of goods and/or services from Events N Yu will be made in accordance with the terms and conditions of this Application and any invoices and/or other documents evidencing Applicant’s obligations to Events N Yu, all of which are incorporated herein by this reference.
3. The entire outstanding balance due to Events N Yu on all invoices is due upon receipt.
4. The entire outstanding balance due to Events N Yu on all invoices shall become due in full immediately upon default in the payment of any invoice. Applicant agrees to pay interest in the amount of 1.5% per month, or the highest rate permitted by law, whichever is less, on any past due amount until collected, and Applicant agrees to pay all costs of collection incurred by Events N Yu, including attorneys’ fees and expenses, should a default in payment or any other obligation to the Applicant to Events N Yu occur.
5. If this Application is not fully approved or if any other adverse action is taken with respect to Applicant’s credit with Events N Yu, Applicant has the right to request within 60 days of Events N Yu’s notification of such adverse action, a statement will be provided with 30 days of said request. To obtain the statement of specific reasons, please contact our credit department. The Federal Equal Credit Opportunity Act prohibits creditors from discrimination against credit applicants on the basis of race, color, religion, national origin, sex, marital status, or age (provided that the applicant has the capacity to enter into a binding contract); because all or part of the applicant’s income derives from any public assistance programs; or because the applicant has in good faith exercised any right under the Consumer Credit Protection Act. The federal agency that administers compliance with this law concerning the creditor is the Federal Trade Commission, Washington, D.C.
6. If Applicant has guaranteed the account with a credit card, the Applicant agrees that any invoice aging over 45 days will be processed to this credit card without prior notification.
7. This Application and all transactions between Applicant and Events N Yu shall be governed by and interpreted in accordance with the laws and decisions of Washington, D.C. without regard to the conflicts of law provisions thereof and all actions and proceedings arising from, relating to or in connection with this Application shall be subject to the exclusive jurisdiction of said state.

Applicant hereby certifies that the information furnished under this Application and any other financial statements furnished in connection herewith, is true and correct and that this information is being furnished to Events N Yu to extend credit to Applicant, and understands that Events N Yu intends to rely upon such information. Applicant understands and agrees to be bound by the above terms and all invoices and other documents furnished by Events N Yu from time to time, all of which are incorporated herein by reference,

and to advise Events N Yu of any material change in the information provided herein, including but not limited to, change in ownership, address or telephone number. Applicant understands that Events N Yu will retain this Application whether or not it is approved.
